

Contract for Restaurant Consultation

I. Parties Involved

- a. Jamie Carl, hereinafter "The Deglutenizer," and _____ (Owner/Operator) of _____ (Restaurant name, hereinafter "The Restaurant") agree to collaborate in the development and implementation of a gluten-free menu for The Restaurant on this date _____ (start date).
- b. The Deglutenizer and The Restaurant agree that the gluten-free menu developed for The Restaurant is viable for one year, to be re-negotiated or cancelled on this date _____ (end date, 12 months after start date). Terms of this contract may be re-negotiated at any time prior with initials of both parties and notarization.

II. Terms of Menu

- a. The Restaurant agrees to purchase of menu items in one of two menu types:
 - Single, permanent menu: \$8,000
 - Seasonal menu (permanent menu with rotating seasonal options): \$12,000

III. Payment options:

- First five client discount: 40% off the normal price if The Restaurant is one of the first five clients to sign on for consultation service with The Deglutenizer. (stackable with lump sum discount for a potential 50% discount in total).
- Soft launch discount: 15% off the normal price if The Restaurant signs on during the soft launch period (through 12/31/2018). (stackable with lump sum discount for a potential 25% discount in total).
- Lump sum: The Restaurant agrees to pay in full at time of contract acceptance. This payment method will include a 10% discount off of the normal price.
- Financing: The Restaurant agrees to pay a down payment of _____ (down payment amount) plus remaining menu price in _____ monthly installments to be collected on the _____ (date) of each month for a monthly payment amount of _____ (monthly payment amount). If at the end of the contract period the balance is not paid, the remainder will have 10% interest applied, and the remaining balance plus interest must be collected. If The Restaurant fails to pay balance in timely manner and wishes to re-negotiate the contract at the end of one year, financing will not be offered at the time of re-negotiation and The Restaurant must pay in full at that time.

IV. Liability

- a. The Restaurant agrees to pay The Deglutenizer the amount agreed to in the contract, and does not hold liable The Deglutenizer for additional expenses, loss of profit, injury, or damages.
- b. The Deglutenizer agrees to work with The Restaurant to develop a practical gluten-free menu with consideration to The Restaurant’s kitchen facilities, ingredients budget, and staff constraints.

V. Services Included

- a. Gluten-free menu items & training of kitchen staff on preparation
- b. Recommendations for equipment placement and use to minimize cross-contamination risk
- c. New design files for regular menu to include gluten-free items, plus full-page gluten-free menu
- d. Listing on “Restaurant Partners” page of restaurants.thedeglutenizer.com
- e. Regular posts about gluten-free menu at The Restaurant on The Deglutenizer social media accounts
- f. Inspections of kitchen and procedures 4x per year, and in response to customer complaints

VI. Statement of Agreement and Signatures

- a. The Deglutenizer and The Restaurant agree to the terms outlined herein, and agree to such terms for a period of one year beginning from the date of _____(date). Changes to the terms of this contract must be initialed by all parties and notarized.
